THE HIND RAJAB FOUNDATION

The Hind Rajab Foundation (HRF) is a non-profit registered under Belgian law, dedicated to the quest for justice in response to the crimes against humanity, war crimes and human rights violations perpetrated by the Israeli state against Palestinians. Established during the ongoing Gaza genocide, the foundation honours the memory of Hind Rajab and all those who have perished or suffered under the Israeli genocidal campaign.

HRF's core mission is to actively pursue legal action against those responsible for these atrocities, including perpetrators, accomplices, and inciters of violence against Palestinians. Through offensive litigation, HRF aims to hold these actors accountable in both international and national courts, challenging the culture of impunity that has allowed such crimes to persist.

HRF's litigation activities

Over the past two years, HRF has monitored and documented the conduct of several thousand Israeli military personnel. This work is based on systematic collection and analysis of open-source material, witness accounts, and other evidentiary sources, with the aim of identifying individual criminal responsibility and enabling the submission of complaints.

To date, HRF has submitted more than 70 criminal complaints in 25 jurisdictions across Europe, the Americas, Asia and Africa. Sixteen of these complaints concern members of the Givati Brigade and three concern the 401st Brigade. The complaints have been filed pursuant to national legislation providing for universal or extraterritorial jurisdiction over international crimes. HRF has also filed 19 Article 15 Submissions to the International Criminal Court.

A number of these filings have resulted in procedural developments. In Brazil, the Federal Court of the Federal District, acting on authorization from the Federal Prosecutor, issued an urgent order instructing law-enforcement authorities to investigate and take action against a suspect identified in a complaint submitted by HRF in December 2024.¹ The individual subsequently fled Brazil for Argentina, where an additional complaint was filed, and later returned to Israel. The Brazilian proceedings were subsequently archived.

On 7 May 2025, another complaint by HRF concerning a Givati Brigade soldier was referred to the Military Prosecutor's Office of the Bucharest Military Court of Appeal for further examination.²

On 11 June 2025, one of HRF's complaints in Peru was transmitted to the Human Rights Prosecutor's Office, thereby advancing the matter from an initial jurisdictional review to the preliminary investigative phase.³

On 18 July 2025, HRF filed a complaint in Belgium against two Israeli soldiers, in cooperation with the Global Legal Action Network (GLAN).⁴ Belgian federal police arrested and questioned the two individuals at the Tomorrowland festival in Boom. Although the individuals were later released and permitted to leave Belgian territory, the case proceeded further.⁵ On 29 July 2025, the Belgian Federal Prosecutor transmitted the case to the International Criminal Court pursuant to Article 14/10 of the Belgian Criminal Code.

EXECUTIVE SUMMARY

1. This report was prepared by the Hind Rajab Foundation (HRF) and presents evidence concerning the alleged involvement of **Guy Hochman**, an Israeli reservist, in crimes during the Israeli military campaign in the Gaza Strip (Gaza). The findings are based on open-source information collected and preserved by HRF's investigative and legal team using structured monitoring methods and digital forensic tools.
2. **Guy Hochman** is an Israeli stand-up comedian and online content creator. He gained prominence during Israel's war on Gaza through his close alignment with the Israeli military and pro-war messaging. A former combat soldier, he has publicly stated that after October 7, 2023, he attempted to rejoin his battalion as a reservist but was rejected due to testicular cancer. Following this, he began producing and disseminating videos with Israeli soldiers, after which he was recruited as an entertainer linked to the IDF Spokesperson's Unit—an unusual role for a civilian performer. He was deployed to Gaza as part of a campaign of moral boosting and to create content for the Israeli military on social media.
3. His appearances, many recorded in military uniform and distributed online, have included messaging that glorifies mass killing, use of nuclear weapon against Gaza, destruction and occupation of Gaza, as well as messaging that promotes revenge and cruelty against Palestinians.
4. HRF's investigation in the present case establishes that **Guy Hochman** may have been involved in the attack on and destruction of the Raed al-Attar Mosque in Rafah, the obstruction of humanitarian aid and the incitement to commit war crimes and genocide.

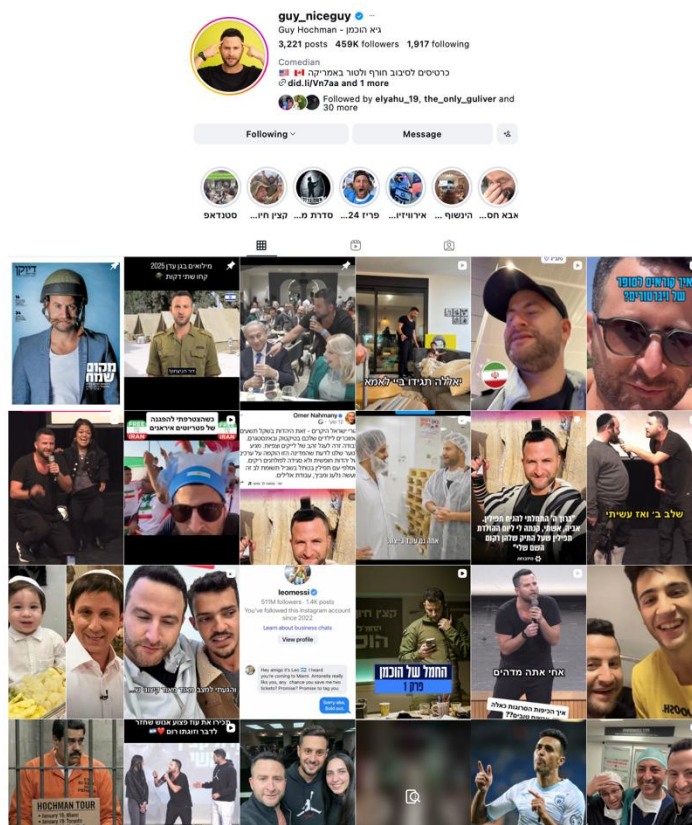


METHODOLOGY

5. The findings in this report are based on open-source information collected, verified, and preserved by HRF's investigative and legal team. This information was obtained using structured monitoring methods and digital forensic tools in accordance with international standards (e.g. the Berkeley Protocol⁶ and ICC guidelines⁷).

6. Over the past 17 months, HRF has carried out a comprehensive investigation into the Israeli army, closely monitoring over thousands of personnel. As part of this investigation, HRF identified **Guy Hochman (Exhibit 1)**.

7. To capture and preserve evidence, the investigative team uses Hunchly.⁸ Hunchly is a forensic web capture tool designed to assist investigators, journalists, and legal professionals in preserving digital content in a verifiable and tamper-resistant format. It automatically captures and timestamps each visited webpage, saving the full HTML, screenshots, and metadata in a structured and searchable database. Importantly, Hunchly generates cryptographic hashes for each capture, allowing for verification of the integrity and authenticity of the preserved material. This functionality is essential when seeking to meet evidentiary standards in judicial proceedings.

8. Beyond the forensic capture, HRF preserved additional visual evidence by taking screenshots of the materials and downloading the corresponding photos and videos through third-party software tools.
9. In addition to monitoring social media, the investigation incorporated open-source research investigation, including general search engine queries, review of news articles, media coverage, interviews, and official government or military reports to corroborate findings and contextualize the battalion's operations within the broader military campaign.
10. The report includes selected screenshots and copies of the archived materials to support the factual findings. Upon request, HRF is prepared to provide full access to the original archived content, including the corresponding metadata and capture logs.
11. Upon request, HRF is prepared to provide full access to the original archived content, including the corresponding metadata and capture logs, and any additional materials retained in its custody. Materials not disclosed in this submission have been withheld solely on the basis of relevance and do not affect the integrity or completeness of the findings set out in this report.



GUY HOCHMAN'S PRESENCE IN NORTH AMERICA

12. **Guy Hochman** is scheduled to travel to the United States and Canada for his stand-up show.⁹
13. Open-source information including publicly accessible promotional materials, ticketing websites and his social media confirm **Guy Hochman** is currently engaged in a North America tour.
14. Between 15 – 17 January 2026, **Guy Hochman** attended as a speaker¹⁰ the 10th National Summit of the Israeli American Council (IAC), held in Hollywood, Florida.¹¹

15. During this event, **Guy Hochman** was present together with **Adi Karni**, a known Israeli soldier (**Exhibits 3 and 4**).¹² **Adi Karni** is a former sergeant with the Gideon Company of the 603rd Battalion and reservist, who was deployed to Gaza and took part in operations that resulted in the mass destruction of several civilian structures. **Adi Karni's** social media profiles have been monitored since March 2024 by investigators from the Hind Rajab Foundation. On these platforms, **Adi Karni** documented and glorified the demolition of civilian objects in Gaza. He shared photographs and videos showing his participation in controlled demolitions, smiling as he personally detonated explosives. He also appeared in Israeli media proudly boasting about the destruction conducted. Last year, HRF lodged a complaint with the authorities in Peru concerning alleged war crimes committed by Mr. Karni. On 23 May 2025 the Peruvian authorities announced the opening of a formal investigation into those allegations, and on 11 June 2025 the matter was transferred to the country's specialised Human Rights Prosecution Unit.¹³ Unfortunately, he had already left the country. Since, **Adi Karni** has travelled extensively, using his public platform to advocate for the Israeli aggressive military campaign, defend the destructions, and disseminate Islamophobic rhetoric.¹⁴

16. On 17 January 2026, **Guy Hochman** published an Instagram Story promoting his remaining tour dates in North America, including scheduled performances in the United States and Canada, thereby confirming his planned travel itinerary and anticipated presence in Toronto, Canada (**Exhibit 5**).

17. On 18 January 2026, **Guy Hochman** performed in Miami, United States, as part of his tour. He then travelled to Toronto, Canada, where he was detained at the airport for several hours following a complaint by HRF and several other Canadian organisations. He was subsequently released after intervention by Israeli officials.¹⁵ He performed his stand-up show in Toronto on 19 January 2026.

18. Available tour schedules indicate that following his Toronto performance on 19 January 2026, he will return to the United States for a performance in New York on 20 January 2026.¹⁶

19. **Exhibits 6 and 7** show the Toronto performance, including venue details and ticket availability. These materials confirm that Guy Hochman's entry into Canada is planned for 19 January.

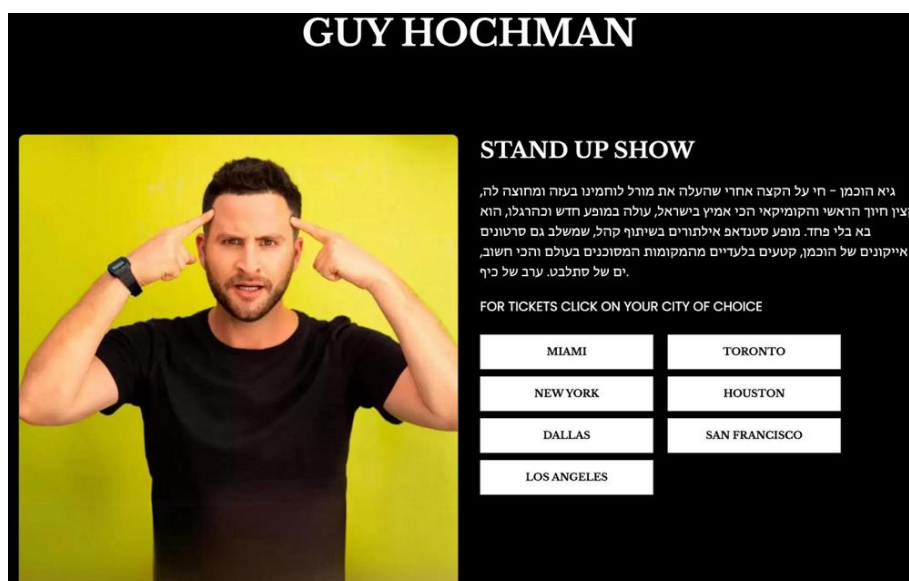
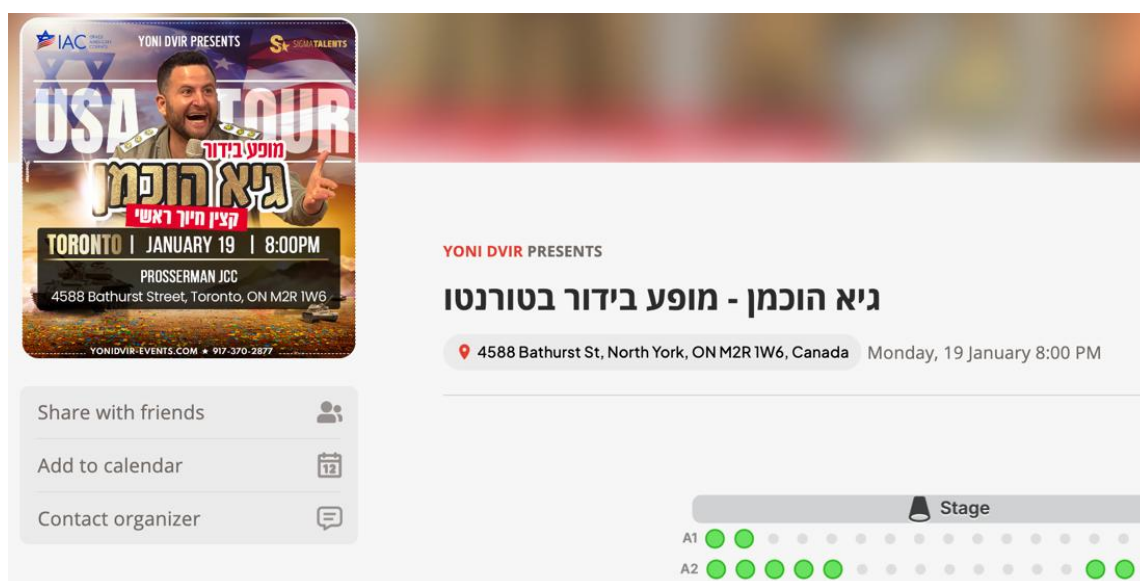


Exhibit 7 – Website of ticket sale for Guy Hochman's standup in Toronto, Canada

GUY HOCHMAN'S PROFILE

20. **Guy Hochman** is an Israeli and Greek citizen who operates multiple public social media accounts, including an Instagram account [@guy_niceguy](https://www.instagram.com/guy_niceguy/),¹⁷ a X account [@hochmanguy](https://x.com/HochmanGuy),¹⁸ a Facebook account,¹⁹ a TikTok account [@guy_niceguy](https://www.tiktok.com/@guy_niceguy),²⁰ and a YouTube Channel [@guyhochman3151](https://www.youtube.com/@guyhochman3151).²¹

21. His full name is **Guy Hochman (Exhibit 1)**. He is born on 13 October 1988 and lives in Israel.

22. **Guy Hochman**, former Israeli soldier, is now a stand-up comedian and online content creator with a significant public following.²² After 7 October 2023, he publicly stated in interviews and social media content that he immediately sought to rejoin his battalion as a combat reservist but was rejected on medical grounds, due to testicular cancer (see **Exhibit 15 below**). Following this, he began producing and disseminating videos with Israeli soldiers. After the Israeli army became aware of his activities, he was recruited into the army in a reserve capacity associated with the IDF Spokesperson's Unit, where he described his role as contributing to soldiers' morale. In his new role, his performances were recorded and uploaded to his social media platforms.

23. On 7 October 2023, **Guy Hochman** published a public Instagram post (**Exhibit 8**) with the caption in Hebrew stating: *"How is it that in the communities around the Gaza border, families have been hiding for 10 hours from terrorists who have already murdered hundreds of Israelis, and in Gaza there is still electricity, water, and buildings standing?!?"*

24. On 8 October 2023, **Guy Hochman** posted content addressing the practice of roof-knocking prior to bombardment in Gaza, stating: “*After yesterday, we no longer need to be the most moral army in the world – we just need to be an army.*” (Exhibit 9)

25. On 10 October 2023, **Guy Hochman** published a post stating: “*Forget what I’m trying to do. You know what would really help boost morale? Videos of tens of thousands of dead terrorists and the conquest of Nazi Gaza. Period.*” (Exhibit 10)

26. On 14 October 2023, **Guy Hochman** shared an interview with Israel TV outlet, Channel 12, from the hospital with a caption indicating a transition from reserve military

service to the delivery room and back (**Exhibit 11**). In the video, **Guy Hochman** stated that he intended to do everything possible to return to active duty, explaining that public reactions in Israel encouraged him and that, after years of working as an online influencer, this was the first time he felt he was truly influencing people. When the presenter reframed the goal of the war as victory and internal unity, **Hochman** reiterated that cruelty and revenge were the goal to ensure the safety of children, asserting that this marked the end of moral considerations and restrained language. He further claimed that there were no longer moral limits, described a widespread desire for revenge among those on the ground, and framed the events as a defining historical moment for the Jewish people.

27. On 15 October 2023, **Guy Hochman** reshared an Instagram post titled “Simple Math” (**Exhibit 12**). The post contained the following text (translated from Hebrew): “*The UN is asking for a proportional response. So here, a little proportion: For Gilad Shalit, we released 1,027 prisoners. One Jew is worth 1,027 terrorists. 1,350 murdered Jews times 1,027 equals...1,386,450 casualties in Gaza. That is the proportion we have gotten used to. Glad to help.*”

28. Thereafter, **Guy Hochman** began producing and disseminating video content featuring Israeli soldiers during the ongoing military campaign in Gaza. These footages were filmed with **Guy Hochman** wearing Israeli military uniform and were uploaded to his social media platforms.

29. On 19 October 2023, **Guy Hochman** posted: “*I went down to the field. So much poison (slang for drive or motivation). Not a single mosque will remain in Gaza.*” (**Exhibit 13**).²⁸

30. **Guy Hochman** posted on X on 20 October 2023 a drone footage of multiple residential bombings with the caption that translates to, “*The Jewish people are returning to being cruel. Jewish revenge on Jewish land.*” The same post appeared on his Instagram account (**Exhibit 14**).

31. On 21 October 2023, during a Channel 12 report, **Guy Hochman** confirmed that, after the Israeli army became aware of his activities, he was recruited into the Israeli army in a reserve capacity associated with the IDF Spokesperson's Unit, where he described his role as contributing to soldiers' morale (**Exhibit 15**).

32. He publicly referred to himself as the “Chief Smiles Officer” (**Exhibit 16³⁰**) and documented multiple visits to military bases and the Gaza Strip in uniform, including improvised stand-up performances delivered to soldiers during active hostilities (**Exhibit 17³¹**).

33. On 26 October 2023, **Guy Hochman** published a video stating: “*Victory will be complete conquest of Gaza, an Israeli flag hanging over Gaza’s town hall... Victory will be the new Nova festival on the empty field that was once called Khan Younis.*” In the video he can be seen wearing more updated combat gear of the Israeli military (**Exhibit 18**).

34. On 31 October 2023, Guy Hochman reshared an Instagram post originally published by the account @TalOr314 advocating “conquest, expulsion, and settlement” as the response to 7 October 2023, including references to Gaza’s destruction and future settlement (**Exhibit 19**). The content stated, in translation:

*Even if we dismantle Hamas and kill all 40,000 of its terrorists plus another 60,000 supporters of terror, October 7 will be cemented in Palestinian consciousness as a glorious act against the Zionist enemy. The terror movement that replaces it (whether it is Abu Mazen or any other terrorist) will grow up on the stories of October 7 and will aspire to recreate the massacre. **But if we destroy Gaza,** expel the Nazis from there, and settle it as part of the complete Land of Israel, then October 7 will become, in the eyes of the Arab world, not a heroic act but a Nakba, and Hamas will be rooted in consciousness as the terror organization that brought about the destruction of its own people. **There is only one possible answer to October 7: conquest, expulsion, and settlement.***

35. **Guy Hochman** accompanied this reshare with the caption: “*There is no other option. We owe this to our children, to future generations, to our legacy. The Jewish people deserve to walk in safety and with their heads held high in their own land.*”

36. On 2 November 2023, **Guy Hochman** posted a new video from Kibbutz Kfar Aza (**Exhibit 20**). In the video he stated that people should visit the areas affected by the events of 7 October 2023. He then described the Palestinian population in Gaza as "sons of death", an Israeli term referring to someone who should be killed. He asserts that everyone who grows up in Gaza knowingly chooses violence. He dismissed references to Gaza's civilian population and refugee status, rejecting them as irrelevant. He further justified the need to occupy the territory and to seek revenge, stating that this should be pursued regardless of consequences, and cited the killing of babies and children as the basis for this position.

37. On 8 November 2023, responding to the image of Gaza refugees, **Guy Hochman** reshared the image with the caption, “*You carried out a Holocaust, you will receive a Nakba.*” (Exhibit 21)

38. Between 13 November 2023 and 24 November 2023, Guy Hochman published multiple posts on Instagram about his deployment to Gaza. His first post on 13 November 2023, accompanied the statement, “*Missing a testicle, but in Gaza. We will win.*” (Exhibit 22) Two more videos were published on his account capturing his movement within Gaza. In one of the videos he says, “*I am inside Gaza, there is destruction here. The Jewish people are here on the ruins of Gaza... We will fuck them,*” and contains the caption “*History. I will never forget the first video from Gaza. Everything is ours.*” (Exhibit 23)

39. On 14 November 2023, **Guy Hochman** shared a video of an interview with Channel 12, featuring several of his content, including **Exhibits 22, 23, and 25**.

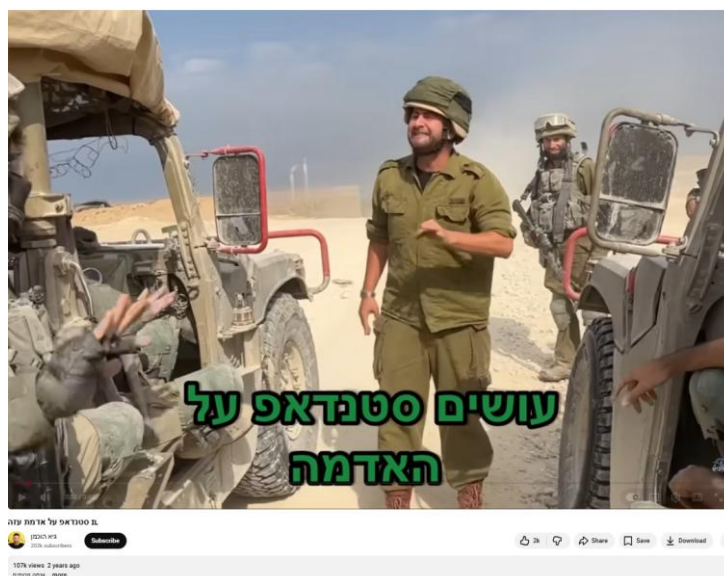
40. On 21 November 2023, **Guy Hochman** also published a video on his YouTube channel (**Exhibit 25**). He appears wearing Israeli military uniform and addressing a group of armed Israeli reservists during an apparent field gathering. In the video, **Hochman** gestures toward the surrounding area and states, in Hebrew, “*look what we did to them*,” referring to Palestinians. He further states that Israelis “*were given this land*,” asserts Israeli ownership over the territory, and urges the soldiers to “*believe in the justice of the path*.” The statements are delivered as part of motivation for the armed reservists during the ongoing military campaign in the Gaza Strip.

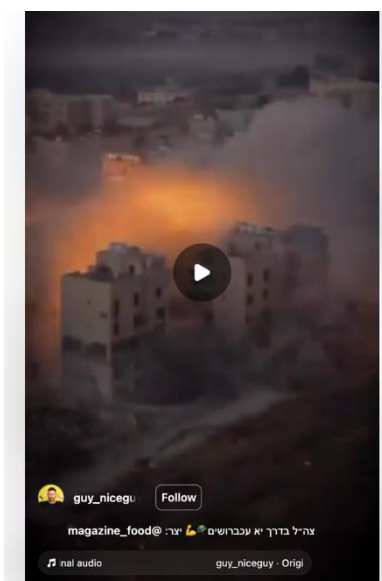

42. On 1 December 2023, **Guy Hochman** posted an Instagram reel that was comprised of multiple footages of aerial bombing and tank bombing of Gaza and Israeli military campaign with the caption “*The IDF is on the way, you rats.*” (**Exhibit 27**)

44. On 7 December 2023, **Guy Hochman** published a video on his Instagram account in which he stated: “*I am coming to conquer Gaza and to give Hezbollah hell, staying true to one commandment: to blot out the descendants of Amalek. I left my home behind, and I will not return until victory. We know our calling: there are no uninvolved.*” (Exhibit 29).

45. On 13 December 2023, **Guy Hochman** reshared an Instagram post with the accompanying text “*Clean up the trash.*” The text post included the statement: “*All of Nazi Gaza cannot exist on the day after.*” (Exhibit 30)

46. **Guy Hochman** continued to document his deployment alongside the Israeli military in Gaza in December 2023. On 26 December 2023, he published two videos on his Instagram and X accounts. The videos were recorded from within Gaza and show him wearing a military

uniform and then undressing and swimming amid destroyed civilian infrastructure (**Exhibits 31 and 32**).

47. The caption accompanying the video in **Exhibit 31** referenced a slogan attributed to former Israeli Prime Minister Yitzhak Shamir: “The sea is the same sea and the Arabs are the same Arabs”.⁴⁵ This slogan is widely understood as denying the possibility of a political solution and portraying Palestinians as possessing an immutable and collective intent to expel Israelis, thereby implying the necessity of their own displacement or destruction.

48. In the video itself, **Guy Hochman** is heard asserting ownership over Gaza (“landlords”) and emphasising that everything there belonged to Israelis, while directing the camera toward nearby buildings. He linked the area to the Nova area, before running into the sea. He further remarked that the sea was no different from that of Ashkelon, questioning why he had come there. The overall content of the video conveys a sense of dominance and entitlement over the territory, while justifying the surrounding destruction of the area.

49. He shared another video recorded at the beach (**Exhibit 32**), accompanied by the caption “Ours.” In the video, he stated that he had been present on the Gaza coastline and repeatedly asserted that the area belonged to them and should be treated as such. He emphasised that this claim of ownership required normalisation. While handling sand from the beach, he alleged that individuals responsible for killing Israeli soldiers and raping Israeli women had previously walked along that same shore and asserted that they should be made to pay. He further stated that, because Israelis had been taken from them, they would take houses, land, and the sea in return.

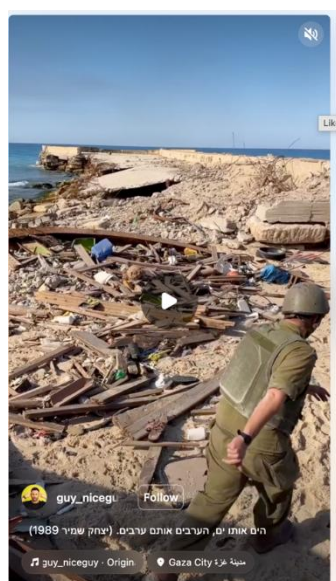
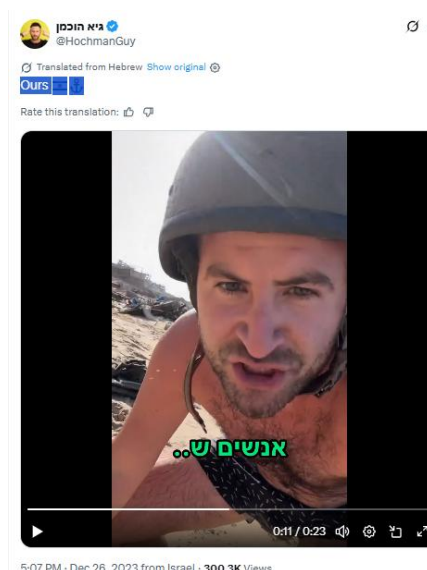

50. On 30 December 2023 and 1 January 2024, **Guy Hochman** published two videos captioned “*Happy New Year wishes from our soldiers in Gaza.*” (**Exhibits 33 and 34**) The

51. On 17 January 2024, during an interview with an Israeli news outlet captioned “*Where were the hypocrites of The Hague on October 7th? To defend ourselves, by ourselves* 🇮🇱”, **Guy Hochman** was asked whether his public statements could be detrimental to Israel in light of the proceedings before the Court in The Hague (**Exhibit 35**). In response, he stated that he was not concerned with developments in The Hague and emphasised that his focus was instead on maintaining a connection with Israeli combatants operating in Gaza. He dismissed the relevance of the court proceedings, characterised the public discussion surrounding them as a spectacle, and asserted that his role was to give voice to the people, drawing his message from realities on the ground. The interviewer then raised concerns about the possibility that a decision from The Hague might require Israel to halt the war, potentially causing international damage. **Guy Hochman** replied that, regardless of international opinion, military operations should not be halted midway. He maintained that Israel must complete its objectives and continue to defend itself while upholding what he described as high moral standards.

53. On 26 January 2024, **Guy Hochman** published a post from inside Gaza addressed to South Africa, stating: “*A message to those bastards in South Africa. ‘Happy Hague’ [a wordplay on Happy Holiday], we keep fighting with full force. No humanitarian aid, no mercy, with balls.*” The post includes images of **Hochman** wearing military gear in the middle of visible destruction (**Exhibit 37**).

54. In January 2024, he also participated in the blocking of aid trucks, recorded videos from Kerem Shalom in which he called others to join and block the trucks. In one of the videos, he says, among others, “these are weapons for our enemies.” (Exhibit 38(1)). Exhibit 38(3) is captioned: “If there are 50,000 likes here, I’ll block every aid truck to the Nazis with my body, with my face, and with my balls.”

55. On 12 June 2024, **Guy Hochman** published a video filmed inside Gaza stating: “Every drive here is a little revenge.” The video shows **Hochman** wearing an Israeli military helmet and protective vest while moving through Gaza and captures movement around Gaza including destruction of civilian infrastructure, civilian residential buildings and Israeli military soldiers (**Exhibit 39**).

56. On 19 July 2024, **Guy Hochman** shared a very distressing message on Instagram, calling for the use of the nuclear bomb on Gaza. “Keep containing instead of speaking Arabic, and that’s what we’ll get. I guess we’ll have to wait for Trump to get elected so that we’ll be able to use the doom’s day weapon. And we have one of those...”

57. On 6 September 2024, **Guy Hochman** shared an image from Gaza showing an Israeli soldier raising an Israeli flag amid extensive destruction, accompanied by a caption identifying the commander of the 932nd “Granite” Battalion of the Nahal Brigade. In the caption, he states that he served in the Battalion in the past. The caption reiterates that the flag of Israel is “*being flown in the heart of the Tel Sultan refugee camp*”.

58. Tel Sultan refugee camp is one of eight Palestinian refugee camps in the Gaza Strip. It is in the Rafah Governorate just north of Rafah city. On 26 May 2024, the Israeli Air Force bombed a displacement camp in Tel al-Sultan, Rafah. The attack, which set the camp on fire, killed between 45 and 50 Palestinians and injured more than 200.⁵⁸

59. **Guy Hochman**’s involvement with Israeli military personnel and military-related was also documented by Palestinian journalist, Younis Tirawi. On 25 September 2024, he shared a video showing **Guy Hochman** with Israeli forces inside Raed Al-Attar Mosque in Rafah (Coordinates: 31.320277, 34.232745⁶⁰). The destruction of the Mosque was recorded using drone footage and reportedly shared in far-right messaging groups.⁶¹ The video footage circulating online shows Israeli soldiers, including **Guy Hochman**, setting up and detonating explosives inside the Mosque, resulting in its complete destruction (**Exhibit 42**).

60. On 16 August 2025, **Guy Hochman** shared on X a footage from what appears to be a guest on a recorded show or interview segment.⁶³ During the exchange, the presenter asks Hochman: “*I want to ask you, you hear the story of Lior and do you still think every Gazan is a Hamasnik⁶⁴?*” Hochman replies: “*Yes.*” The presenter then asks, “*Do you want to think again?*” Hochman responds: “*No.*”

61. On 4 November 2025, he shared a video on X of his performance in front of Ketz'iot prison personnel. The caption reads: " I performed yesterday in front of the Ketz'iot Prison fighters, the canons [canon is Israeli slang meaning manly/strong/winner], those who handled Greta the “sharlila” (Greta the prostitute) and the Nukhba terrorists—may their names be erased. Guests of honour were Force 100, who now that everything is becoming clear, deserve compensation for the injustice. We're all with the IDF fighters”⁶⁵

62. Force 100 is the unit responsible for the gang-rape of a Palestinian detainee in the military detention camp Sde Teiman.⁶⁶ The video of the rape was leaked by Israeli military prosecutor Major General Yifat Tomer-Yerushalmi and started international outrage while several Israeli officials sided with the rapists.⁶⁷ As a result, Major General Yifat Tomer-Yerushalmi was arrested, while the soldiers involved in the alleged rape have been released and have seen their charges downgraded to “severely abusing” the victim.⁶⁸

63. In the video, he says, addressing Force 100: “(...) *the people of Israel didn't get confused, I am meeting everyone and you are our heroes, you are our canons, you were given the hardest task and you should have an honorary military ceremony in Sde Teiman*”.

FACTUAL ALLEGATIONS

64. Between 7 October 2023 and at least November 2025, **Guy Hochman**, an Israeli public figure and social media influencer who was formally integrated into Israeli military structures in a reserve capacity, engaged in a sustained course of public conduct consisting of statements, audiovisual content, and on-the-ground activities related to the Israeli military campaign in Gaza. This conduct included repeated calls for mass killing, destruction of civilian infrastructure, forcible displacement, denial of civilian status to the Palestinian population, and the removal of moral or legal restraints on the use of violence.

65. Throughout this period, **Guy Hochman** used his large social media following and access to Israeli soldiers and military zones to disseminate messaging that dehumanised Palestinians as a group, portrayed them as collectively culpable, denied the existence of uninvolved civilians, and explicitly advocated for mass murder and destruction. His statements were made publicly and repeatedly.

66. **Guy Hochman** also actively participated in and encouraged actions aimed at obstructing humanitarian assistance to the civilian population of Gaza. He also appeared in footage documenting the destruction of a mosque.

Destruction of Raed al-Attar Mosque in Rafah

67. **Guy Hochman** was present in the Gaza Strip in the company of Israeli military personnel. He had publicly confirmed that he was serving in a reserve capacity associated with morale-boosting and public engagement activities and documented his presence in Gaza while wearing Israeli military uniform and standard military equipment.

68. On or around 25 September 2024, leaked video footage circulated online depicting Israeli soldiers entering the Raed al-Attar Mosque in Rafah and placing controlled explosive charges inside the structure prior to detonation (**Exhibit 42**). The footage shows **Guy Hochman** inside the mosque with other Israeli soldiers prior to the explosion. He appears in military attire. A drone video footage then captures the detonation, which results in the destruction of the Raed al-Attar Mosque. The explosion produces a large blast cloud and total structural collapse consistent with the use of pre-placed explosive charges.

69. HRF verified the identity of the structure as the Raed al-Attar Mosque through comparison of architectural features visible in the footage with pre-destruction imagery and open-source photographs of the mosque prior to September 2024 (Coordinates: 31.320277, 34.232745⁷⁰).

70. The method of destruction – entry into the structure, placement of explosives, and controlled detonation – indicates a planned operation conducted under conditions of physical control, rather than during active hostilities or immediate combat. No open-source material reviewed by HRF indicates that the Raed al-Attar Mosque was being used for military purposes at the time of its destruction, nor has the Israeli military publicly claimed to have identified military activity or threats inside the mosque prior to the demolition.

71. Prior to the demolition of the Raed al-Attar Mosque, the surrounding area in Rafah had become a site of large-scale civilian displacement. By December 2023, Palestinians who had fled intense Israeli bombardment elsewhere in the Gaza Strip had established extensive makeshift tent camps in the vicinity of the Raed al Attar mosque in Rafah. **Exhibit 43** shows an aerial view dated 9 December 2023 of the makeshift tent camps surrounding the Raed al-Attar Mosque in Rafah. The image depicts hundreds of temporary shelters erected adjacent to the mosque and nearby residential structures, used by displaced Palestinian civilians seeking refuge in the southern Gaza Strip following widespread destruction and evacuation orders issued during ongoing hostilities.

72. Beginning on 6 May 2024, Israel launched a ground invasion of Rafah.⁷² On 7 May, the Israeli military entered and took “operational control” of the Palestinian side of the Rafah border crossing with Egypt.⁷³ This crossing had been a major conduit for humanitarian aid and for patients seeking medical evacuations. Following the takeover, the crossing was destroyed, severing the main exit/entry route for many civilians, including the wounded or sick seeking treatment outside Gaza.⁷⁴ The World Health Organization estimated that in early May 2024, around 2,000 medical evacuations were blocked due to the closure of Rafah.⁷⁵

73. During the assault on Rafah, the Israeli army destroyed homes and infrastructure,⁷⁶ killed dozens of civilians,⁷⁷ and triggered the mass displacement of over one million

Palestinians.⁷⁸ Exhibit 34 was published during this period, which marked a time of extensive and systematic devastation in the city.

74. By January 2025, it was estimated that 49% of Rafah's buildings had been damaged or destroyed.⁷⁹ According to UNOSAT, in December 2024, Rafah became the governorate with the second-highest increase in structural damage, after Gaza City, when compared to damage recorded on 6 September 2024. Approximately 3,054 new structures were damaged in Rafah alone.⁸⁰ Satellite imagery confirmed that vast areas of the city had been levelled.⁸¹

75. Local authorities declared Rafah a "disaster zone" in early 2025. According to the city's mayor, 60% of homes (approximately 16,000 structures) were destroyed, alongside water wells, sewage systems, and key public buildings. The amount of rubble was measured in the millions of tons, and the devastation has rendered safe return impossible for hundreds of thousands of displaced residents.⁸²

76. While airstrikes caused significant damage, much of Rafah's destruction was carried out at ground level through bulldozing and the controlled demolition of entire residential blocks, a process that persisted until the January 2025 ceasefire.⁸³

Dehumanisation of Palestinians and Denial of Civilian Status

77. **Guy Hochman** consistently portrayed Palestinians as an undifferentiated, inherently culpable collective, denying the existence of civilians or protected persons.

- He described the Palestinian population of Gaza as "sons of death," asserted that everyone raised there knowingly chooses violence, and rejected the relevance of civilian or refugee status (**Exhibit 20**).
- He invoked the biblical commandment to "blot out Amalek" and stated that "there are no uninvolved," a phrase widely understood in Israeli discourse as denying civilian status altogether (**Exhibit 29**).
- In August 2025, he publicly affirmed that he considered every Gazan to be a member of Hamas (*Hamasnik*) and refused to reconsider this position when challenged (**Exhibit 44**).

Call for Cruelty, Revenge, and Removal of Moral or Legal Restraints

78. **Guy Hochman** repeatedly rejected legal, moral, and humanitarian constraints on the use of force and framed cruelty as both necessary and virtuous.

- He explicitly rejected military restraint, stating that Israel no longer needed to be "the most moral army in the world," but only "an army," in reference to roof-knocking prior to bombardment (**Exhibit 9**).

- In a televised interview, he stated that cruelty and revenge were the operative goals of the war, asserted that there were “no moral limits,” and framed such cruelty as necessary to protect Israeli children (**Exhibit 11**).
- Across multiple videos from Gaza, he used exterminatory and sexually violent language, including statements such as “we are coming to kill you,” while encouraging soldiers to embrace the “justice” of destruction and conquest (**Exhibits 18–26**).

Incitement to Mass Killing and Extermination

79. **Guy Hochman** repeatedly called for, endorsed, and normalised large-scale killing of Palestinians.

- He stated that morale would be improved by “videos of tens of thousands of dead terrorists” and called for the conquest of Gaza, which he labelled “Nazi Gaza,” conflating the territory and its population with Nazism and thereby justifying unlimited violence (**Exhibit 10**).
- He reshared content advocating a “proportional” response that explicitly calculated the killing of over one million Gazans as an appropriate retaliation for Israeli deaths, thereby endorsing mass killing (**Exhibit 12**).
- He reshared an image of displaced Gazans with the caption “You carried out a Holocaust, you will receive a Nakba,” explicitly advocating mass death and displacement as collective punishment (**Exhibit 21**).
- In July 2024, he publicly advocated for the use of a nuclear weapon against Gaza, stating that Israel possessed such a weapon and implying that its use was delayed only for political reasons (**Exhibit 40**).

Incitement to Destruction of Civilian Infrastructure and Cultural or Religious Sites

80. **Guy Hochman** repeatedly called for or celebrated the destruction of civilian, residential, and religious structures.

- He expressed outrage that Gaza continued to have electricity, water, and standing buildings, implicitly questioning why collective deprivation had not already been imposed on the civilian population (**Exhibit 8**).
- He publicly stated that “not a single mosque will remain in Gaza,” explicitly calling for the destruction of religious sites (**Exhibit 13**).
- He celebrated aerial bombardment of residential areas as “Jewish revenge on Jewish land,” framing widespread destruction as a collective national awakening (**Exhibit 14**).
- In multiple videos from Gaza, he celebrated the destruction of civilian areas as historical, deserved, and irreversible (**Exhibits 22–25**).

Incitement to Occupation and Forced Displacement

81. **Guy Hochman** repeatedly asserted exclusive Israeli ownership over Gaza and advocated for conquest, expulsion, and permanent dispossession of the Palestinian population.

- He asserted exclusive Israeli ownership over Gaza (“everything is ours”), framed destruction as irreversible, and advocated complete conquest, expulsion, and settlement of the territory (**Exhibits 18–26**).



- He published videos from Gaza's coastline asserting ownership of land, houses, and the sea, calling for the normalisation of this ownership and explicitly stating that Palestinian homes and territory would be taken as retribution (**Exhibits 31 and 32**).
- He accompanied these videos with slogans denying the possibility of peaceful coexistence and portraying Palestinians as an unchangeable, hostile collective, thereby justifying permanent displacement or destruction (**Exhibits 31 and 32**).

Obstruction of Humanitarian Aid and Incitement to Collective Deprivation

82. **Guy Hochman** publicly advocated for and participated in actions aimed at denying humanitarian assistance to the civilian population of Gaza.

- In January 2024, he actively participated in and encouraged the blocking of humanitarian aid trucks at Kerem Shalom, describing humanitarian supplies as “weapons for our enemies” and calling on others to physically obstruct aid delivery (**Exhibits 38(1)–38(3)**).
- He publicly called for continued fighting with “no humanitarian aid, no mercy,” while standing amid visible destruction inside Gaza (**Exhibit 37**).

Endorsement and Celebration of Abusive and Criminal Conduct by Military Units

83. **Guy Hochman** publicly praised and legitimised the gang-rape of a Palestinian detainee:

- In November 2025, he performed for personnel at Ketz'iot prison and publicly praised Force 100, a unit implicated in the gang rape of a Palestinian detainee. He referred to its members as heroes deserving honour and framed their actions as national service (**Exhibit 45**).
